INFORMATION CIRCULAR

On the 63rd Session of the United Nations Commission on the Status of Women (UNCSW63)

11-22 March 2019, New York, United States

The priority theme of Session 63 of the United Nations Commission on the Status of Women (UNCSW63) is "Social protection systems, access to public services and sustainable infrastructure for gender equality and the empowerment of women and girls". PSI, in joint effort with ITUC and the Global Unions Federations, has decided to:

Call for:

- The realisation of gender responsive access to public social protection systems, quality public services and sustainable infrastructure for all women, including women migrants, refugees and asylum seekers:
- Bold decisions to prioritize public policies and long-term public investments through tripartite consultations and negotiations.

Be aware of:

• The expansion of corporate power, public-private partnerships, tax evasion, trade agreements on public services as the major barriers for strengthening the role of States in the realisation of women's access to social protection, gender responsive quality public services and infrastructure.

I. PSI DELEGATION

PSI has registered a 20-strong delegation representing affiliates in Africa and Arab countries, Asia, Europe and the Americas. We thank all the affiliates for their enormous response to our call for integrating the delegation.

II. PREPARATION FOR UNCSW63: the next steps

We invite PSI delegates to:

- Organise meetings during February and the first week of March with their respective national bodies
 responsible for the issues of women and gender, ascertain the composition of the official delegation
 to UNCSW63 and present the position of the international trade union movement;
- Inform the PSI Secretariat of the results of meetings with their governments. Based on these reports, we will request a meeting in New York with the accredited government missions of those countries
